

Subject: Documentation of Possible Coordinated Digital and Occupational Interference and Bodily Harm (Since 2020)

I document here events that have occurred since 2020 which, in my view, indicate structured forms of interference. I request examination regarding digital influence, possible coordinated disinformation, mobbing structures, economic disadvantage, or other security-relevant patterns. I have been under effects similar to what international TI case analyses describe — including manipulation of perception, communication, and energetic strain.

### 1. Initial Situation (2020)

At the time, I was employed at Hannoversche Allgemeine Zeitung while simultaneously reaching high visibility on Facebook, particularly through posts on geopolitical developments related to Covid-19.

### 2. Employment Consequences

Shortly after my online visibility increased, my employer initiated my dismissal. I consider this politically motivated, as my employer was aware of my public commentary.

### 3. Digital and Psychological Attacks

Parallel to these events, I experienced unusual occurrences resembling attempts at digital interference, psychological manipulation, or orchestrated campaigns. These included:

- targeted online observation,
- digital intrusions or threat structures,
- psychological or social pressure,
- attempts to destabilize or discredit me.

I cannot technically prove each point, but they fit into known patterns of coordinated influence.

### 4. Reference to Publicly Known Cases

Over the years, I noticed parallels to cases where publicly visible individuals experienced unexplained pressure, threats, or suspicious circumstances. I note this only for contextual pattern analysis.

### 5. Purpose of This Report

My intention is to:

- document events since 2020,
- make potential influence patterns visible,
- register the development with an official body.

### 6.1 Digital Patterns

Following my increased visibility, I noticed:

- unusual account activity,
- abrupt, atypical algorithmic shifts,
- coordinated hostile comments,
- recurring trigger accounts,
- time-synchronized reactions to my posts,
- suspicion of automated monitoring.

## 6.2 Psychological or Social Interference

Additionally:

- isolation within workplace structures,
- disproportionate reactions from supervisors,
- escalative pressure,
- sudden communication cut-offs.

## 6.3 Economic Effects

My dismissal during heightened visibility appeared politically or content-motivated.

## 7. Further Attacks (2020–2024)

In the years after my dismissal, I repeatedly experienced:

- ongoing digital observation,
- intense psychological strain,
- impressions of coordinated influence,
- exhaustion and reduced work capacity.

## 8. Effects on My Mother (2023)

My mother experienced extreme fear reactions and was forcibly admitted to psychiatry, where she later suffered a medical emergency requiring resuscitation. Since then, she has been in a non-communicative state.

## 9. Machete Attack on My Long-Term Partner (09.11.2025)

On November 9, 2025, my long-term partner was attacked with a machete by a male individual. Given our previous visibility and the pattern of events since 2020, I document this as another escalation within a broader context.

## 10. Forced Prostitution Pressure

Due to threats of coercive detention and state-induced financial hardship, I was forced to place escort advertisements. This was not voluntary but a result of structural pressure.

#### 11. Criminal Complaint Against Unknown (02.05.2025)

I file a criminal complaint against unknown persons regarding:

- house search,
- initiation of legal proceedings,
- conviction to 90 daily fines,
- resulting psychological, social, and economic damage.

The complaint concerns suspected structural violence, abuse of authority, and repression targeting my public truth-seeking.

I request review, investigation, and response.
